From Crying to Shaking: Empirical Explorations of the Connection

Ronald G. Barr, MDCM, FRCPC, Developmental Neurosciences and Child Health, Child and Family Research Institute, BC Children's Hospital and University of British Mt. Columbia Faculty of Medicine (Vancouver, BC, Canada)

In a series of "lab analogue" studies using a crying tape or a programmable crying doll, we explore questions derived from the clinical description of abusive head trauma cases; such as (1) do mothers and fathers have different levels of frustration, emotions, unwanted thoughts and urges?; (2) do prepartum and postpartum mothers and fathers or male and female adolescents have different levels of frustration?; (3) do depression, trait anger, or empathy predict frustration responses?; (4) does "successful soothing" result in repeating the same soothing again (as when infants stop crying when shaken); and (5) when adolescents babysit, how frustrating is fussing, crying or inconsolable crying? The findings and their implications for understanding how abuse occurs and how it may be prevented will be presented.

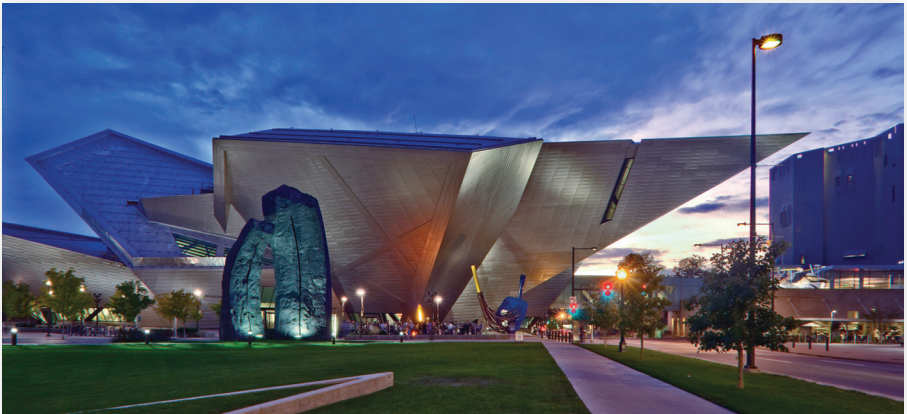

Setting the Record Straight on Abusive Head Trauma for the Courts, Media and Public

Joelle Anne Moreno, JD, Professor of Law, Associate Dean for Faculty Research & Development, Florida International University College of Law (Miami, FL, USA)

Child abuse professionals routinely speak to the public about Shaken Baby Syndrome/Abusive Head Trauma ("SBS/AHT") and many also testify in child abuse and child homicide cases. These responsibilities have always embodied the Herculean task of communicating complex medical and scientific information to judges, juries, and the public. Recently, these challenges have been compounded by a series of troubling television, radio, and print articles. When reporters demand to know -- "Are Innocent Parents Being Prosecuted for Killing their Babies?" -- it makes good copy. But without an accurate understanding of the science, the media will continue to mainstream what are in reality outlier or discredited medical and legal critiques of the foundations of child abuse diagnosis. To correct this campaign of misinformation, which has already redounded to judges, jurors, and other policy-makers, we must develop concrete strategies for a more effective partnership with the media to ensure the promulgation of accurate medical, scientific, and legal information. If the media has been duped into believing that they have uncovered a scandalous medical controversy, the key to correcting this impression will be to make the truth equally compelling.

A Daubert Analysis of Abusive Head Trauma/Shaken Baby Syndrome – Article 2: An Examination of the Differential Diagnosis

Sandeep Narang, MD, JD, FAAP, Fulbright-Nehru Scholar 2014-15, UTHSC-Houston (San Antonio, TX, USA)

The modern scientific literature concerning the diagnosis of physical child abuse has developed for nearly a half century, benchmarked by The Battered Child Syndrome. A few articles in the last two decades have challenged the science for diagnosing Abusive Head Trauma (AHT). In turn, these relatively limited challenges by very few physicians have been used to argue that there is insufficient science to support convictions for Abusive Head Trauma to children in general. It appears that by attacking specific ways of characterizing AHT, e.g. attacking use of one grouping of symptoms termed “Shaken Baby Syndrome,” some critics are creating an unjustified halo of doubt as to any diagnosis that a particular closed head injury is abusive. This workshop first very briefly summarizes current concepts that are crucial to the evaluation of sound medical literature and evidence-based medicine, and the false creation of “controversy” on the topic. In its crux, we will examine the leading and current medical articles on AHT with a particular focus on the best recent research, and it’s “reliability” in a medico-legal context. Finally, we will closely examine key medical diagnoses that are proffered by defense experts as alternatives to AHT. In that vein, we will examine their medico-legal “reliability”.

Understanding Mechanisms of Retinal Hemorrhage through Experimentation, Mechanical Testing, and Imaging

There is a relative paucity of experimental data upon which to infer mechanism and injury thresholds for traumatic retinal hemorrhages in young children. Dr. Binenbaum and Dr. Coats will present the clinical and biomechanical research that they have performed in their own labs as well as their collaborative work on this challenging issue. Research presented will include animal investigations of intraocular pressure changes, clinical epidemiological studies of retinal hemorrhage patterns, changes in the mechanical properties of the eye with age, and evaluation of collagen and adhesive force at the vitreoretinal interface at different stages of development.

Developing a Better Method of Understanding SBS through Biomechanical and Pathological Research

Biomechanics is the study of mechanical forces applied to the human body, and how the human body responds to those forces. The complexity of the brain, the multitude of potential injuries from head trauma, and the gradient of severity of each of those injuries requires that pathological research be studied alongside biomechanics in order to truly understand pediatric head trauma. In this presentation, I will present a summary of the findings from years of biomechanical and pathological research on pediatric head trauma. I will describe the state of the art in abusive head trauma biomechanical and animal models, and discuss paths that need to be explored in order to get some definitive answers regarding the phenomenon of Shaken Baby Syndrome.

There are two important questions the clinicians are routinely asked to testify in court. One is to confirm that the neurological injuries are consistent with abusive head trauma and second is to establish the time frame over which these injuries might have occurred. In this session we will review the neuroimaging findings of abusive head trauma and also discuss the role and limitations of neuroimaging in timing abusive head trauma.

Increasingly, public systems and policy makers are looking at investment in prevention programming from a cost benefit lens. In an effort to demonstrate the cost benefit of investing in effective shaken baby syndrome/abusive head trauma (SBS/AHT) prevention, study authors conducted a two year study to estimate the lifetime individual and societal costs of SBS/AHT. 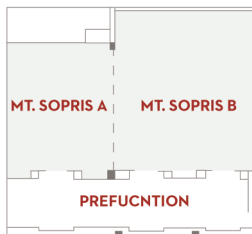

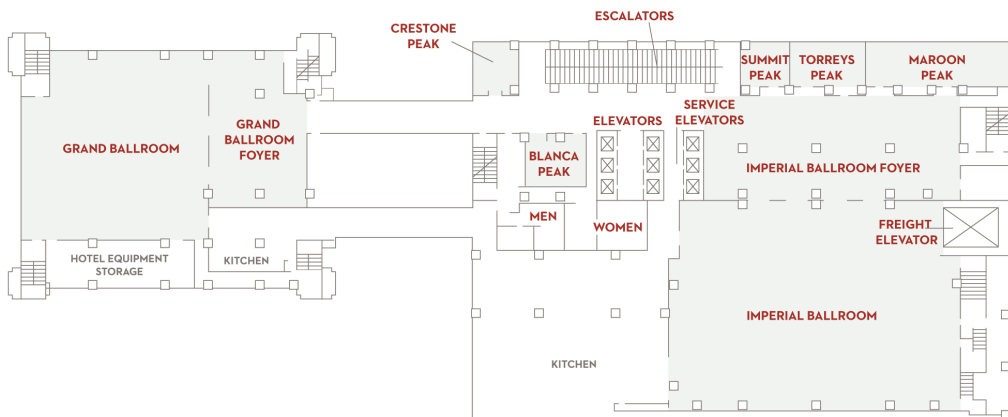
FLOOR PLAN

Grand Hyatt Denver Floors

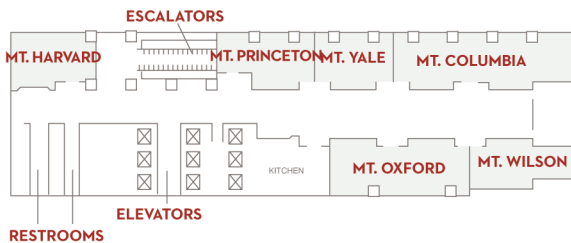

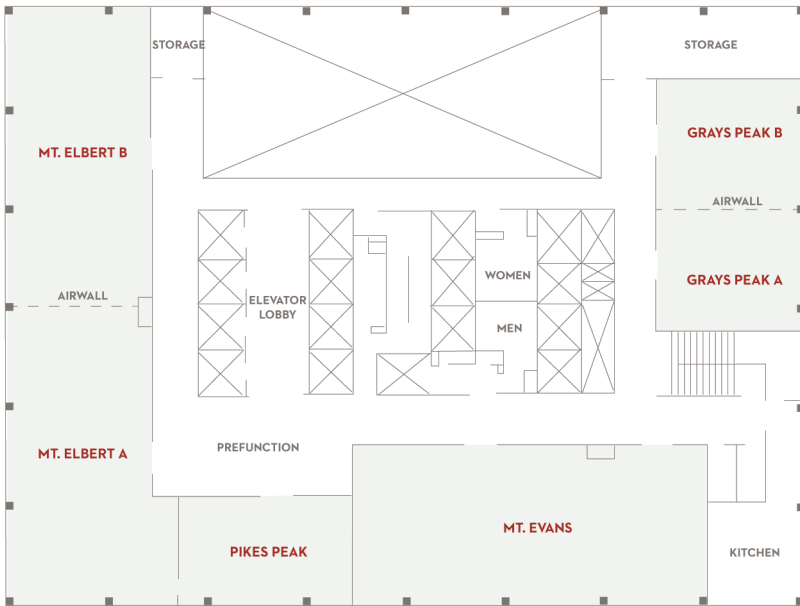
floor plan - atrium tower



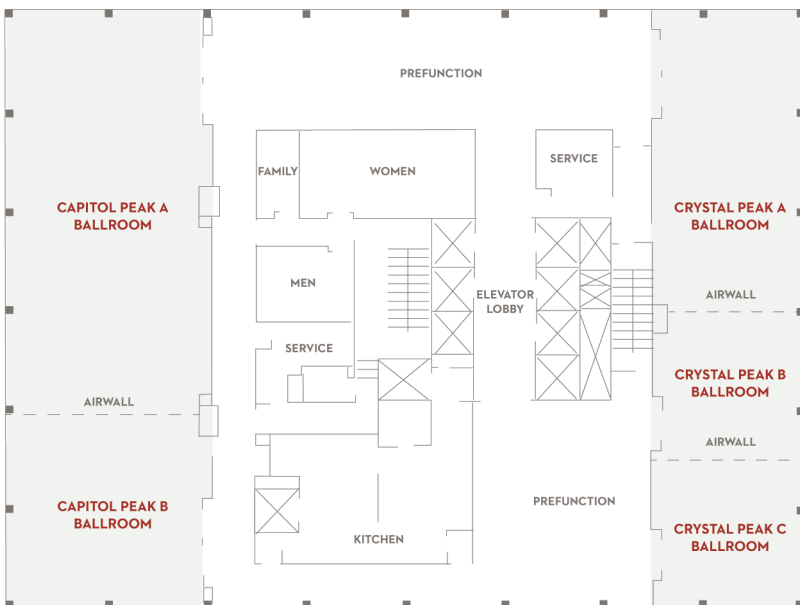
FLOOR PLAN
